**INTERNATIONAL OPEN CALL for EXPRESSION OF INTEREST
for the nomination of five (5) external members of the University of
Macedonia (UoM) Administrative Council (Board)**

The Rector of the University of Macedonia taking into consideration the new provisions of Law nr. 4957/2022, articles 8 and 10 *"New Horizons in Higher Education Institutions: Strengthening the quality, functionality and connection of H.E.I. with society and other provisions"* (A' 141) and of Law Nr. 4727/2022 *"Digital Governance (Incorporation into Greek Law of Directive (EU) 2016/2102 and Directive (EU) 2019/1024) - Electronic Communications (Incorporation into Greek Law of Directive (EU) 2018/1972) and other provisions"* (A' 184) as well as the fact that the term of office of the currently serving UoM Rectors, following its extension and by virtue of the sixty-sixth article of Law 4917/2022 (A' 67), expires no later than 28.2.2023 and thus the election of the Administrative Council (Board) at UoM is obligatory

Hereby Decides

To issue an international open call of expression of interest for five (5) positions of external members of the UoM Administrative Council (Board) in accordance with article 10 of Law 4957/2022.

The term of office of the UoM Administrative Council (Board) begins on the day of its constitution and ends on August 31st 2026.

Candidates eligible to submit for the position of an external member of the Administrative Council (Board) are all individuals holding a position of a Professor at a foreign University or an Emeritus Professor or a former faculty member of any other Greek H.E.I., as well as individuals of international renown and with a significant contribution to the field of culture, arts, academia or sciences, economy or society, and/or representatives of international organizations or partners of social entities.

Candidates who wish to apply for the position of an external member of the UoM Administrative Council (Board) should display formal and substantial qualifications, and hold at least one (1) degree of a Greek or an International H.E.I.

Applications should be submitted online by the interested parties at the email address: **protocollo@uom.edu.gr**, and should include an application form of interest (using the attached sample format) accompanied by supporting documents.

The official deadline for submitting applications is October 5, 2022, Wednesday, at 3:00 p.m. Greek time.
