

Dimitrios E. Akrivoulis Associate Professor of International Political Relations in the Balkans (PhD in International Relations, University of Kent, UK, 2002, LLB and LLM in International Studies, Law Faculty, AUTH. He taught under a teaching scholarship and later under contract at the Dept of Politics and IR of the University of Kent; as a teaching assistant at the Law Faculty of AUTH; as a lecturer and as an assistant professor at the Dept of Balkan Studies of AUTH-UOWM; as a visiting professor at the Dept of International Relations of Bilkent University, Ankara, at the MA in Political Science and the MBA of University American College Skopje, at the European MA in Human Rights and Democratization of the UNESCO Chair of AUTH in collaboration with the Inter-University Centre for Human Rights and Democratization, Venice, at the Dept of Political Sciences of AUTH and at the Dept of Economic Sciences of UOM. He served, among others, as a member of the Research Committee and of the Quality Assurance Unit of UOWM, as well as legal advisor of UOWM and of the Research Committee of that institution; as the head of the Appeal Committee on Public Tender Procedures of UOM, and Coordinator of the Internal Evaluation Unit of the Dept of BSOS. He is the coordinator of the Hermeneutics and Politics panels at the Political Studies Association, elected Board Member of the Hellenic Society of International Law and International Relations, and coordinator (with K. Kentrotis) of the open lecture series on international political theory *Politics First* of the Dept of BSOS. His research interests focus on IR Theory (international political theory) and continental political thought, with an emphasis on Paul Ricoeur's hermeneutic phenomenology, applied especially in the field of humanitarian intervention, collective memory, the social imaginary, and the use of metaphors from natural science to international political thought. One of his monographs has received an award by the Hellenic Parliament.
